Terms and Conditions

General

- Course enrolment and/or other fees relating to the programme will only be recognised upon receipt of payment.
- All course fees quoted are exclusive of SST unless otherwise stated and must be paid in full prior to early access.
- NAMLIFA reserves the right to make changes to the course, date, time and cancel the course due to unforeseen circumstances.
- NAMLIFA reserves the right to alter the course fees.

Course withdrawal and refunds

- Withdrawals from the course are accepted up to 10 days prior to the commencement of the workshops and will incur an administration fee of RM100.
- Request for withdrawals must be made in writing and emailed to <u>info@namlifa.org.my</u>.
- After receiving the notice of withdrawal in writing, NAMLIFA will refund 100% of the tuition fee paid (less the administration fee) within 30 days.
- All tuition fees are non-refundable less than 10 days prior to the commencement of the workshops.

Attendance and assessment

- In order to meet the attendance requirement for the course, the student must attend a minimum of 80% of all training sessions.
- In order to meet the assessment requirement for the course, the student must complete and pass their assessments by the due date.
- Should the student fail to meet the assignment requirement (minimum 50% pass mark) for the course on the first attempt, the student will be granted a second and final assignment attempt 7 days after the first attempt's result release.
- Should the student fail to meet the exam requirement (minimum 50% pass mark) for the course on the first attempt, the student will be granted a second exam attempt within 7 days of the first attempt's result release.
- Should the student fail to meet the exam requirement (minimum 50% pass mark) for the course on the second attempt, the student will be granted a third and final exam attempt within 7 days of the second attempt's result release.
- NAMLIFA reserves the right to take the following steps should the student fail to meet the attendance requirement of the subject and/or the assessment requirement for the course:
 - > Record a 'fail' grade on the student's record for the course; or
 - > Transfer the student to the next available workshop intake on a case-by-case basis should the student wish to continue their study in the programme.
- Should the student fail to meet any assessment attempt for the course due to experiencing an unanticipated serious illness, medical emergency, personal trauma, bereavement (due to immediate family member), or serious illness of an immediate family member they are caring for, the student may apply for special consideration.
- In the event of special consideration and subject to approval, NAMLIFA reserves the right to take the following steps:
 - Record a 'fail' grade on the student's record for the course; or
 - > Transfer the student to the next available intake on a case-by-case basis should the student wish to continue their study in the programme.
